## **Get Started**

Do you live in Washington, Clatsop, Columbia, Tillamook, or Yamhill County? If YES, call or drop-in to the Hillsboro office to talk with a MAT coordinator:

- ► Hillsboro Location Telephone: 503-713-9155
- ► In person: Monday-Friday, drop-in 9:30am-11:00am for a same-day consultation with the program coordinator
- ▶ MAT office hours are 9:30am-5:00pm but availability is limited

Do you live in Multnomah, Clackamas, or another county? If YES, the pathway is to engage with Withdrawal Management (detox) services:

- ► Cherry Blossom Location Telephone: 503-713-9156
- ► In person: Monday-Saturday, drop-in 7:00am-7:30am to Fora Withdrawal Managment (detox)
- ▶ Patients may enroll in MAT services before discharging from Withdrawal Management (detox). Patients also have access to MAT if enrolled through Outpatient services.

#### **MAT Medications**

- Buprenorphine (most common brand names Suboxone and Subutex) for opioid use disorder
- Naltrexone tablets and Vivitrol® injection
- Injectable form of Buprenorphine, called Sublocade® and Brimadi®
- Naloxone (Narcan), the medication that reverses an opioid overdose
